BOMANITE FLOOR CLEANER NEUTRAL pH CONCENTRATE

PRODUCT DESCRIPTION

Bomanite Floor Cleaner will clean floors sealed with Bomaseal I-18, Bomaseal VOC II, Bomaseal I-27, Bomanite Hydrocoat, Bomanite Clear Cure, Bomanite Color Cure, or Bomanite Interior Floor Finish, without affecting the sealer coating, when used according to directions. Bomanite Floor Cleaner rinses easily without excessive foaming.

APPLICATION

For moderately soiled floors, use four to eight ounces Bomanite Floor Cleaner per gallon of water. For light floor cleaning, use one to two ounces Bomanite Floor Cleaner per gallon of water. For cleaning all other surfaces, concentrations can be adjusted from one ounce per gallon of water depending on the amount and type of soil.
